

**RESOLUTION NO. 30 - 12**

**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF BUCKEYE, ARIZONA, ADOPTING NEW RATES AND FEES FOR THE TOWN OF BUCKEYE MUNICIPAL AIRPORT; PROVIDING FOR REPEAL OF CONFLICTING RESOLUTIONS; AND PROVIDING FOR SEVERABILITY.**

**WHEREAS**, the Town of Buckeye desires to update its current Buckeye Municipal Airport Rates and Fees (“Rates and Fees”);

**WHEREAS**, by Resolution No. 09-07, the Mayor and Town Council declared as a public record that certain document entitled “Town of Buckeye Schedule of Fees and Charges” (the “Schedule”) and adopted such Schedule; and

**WHEREAS**, the Town of Buckeye Airport Advisory Board has reviewed and recommends approval of the revisions to the current Rates and Fees contained in this Resolution.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF BUCKEYE** as follows:

**Section 1.** The recitals above are hereby incorporated as if fully set forth herein.

**Section 2.** The Rates and Fees set forth in Exhibit A attached hereto are hereby adopted and shall become effective May 1, 2012, and all prior rates, fees and charges for the Town of Buckeye Municipal Airport are hereby repealed as of that date.

**Section 3.** The Schedule is hereby amended as set forth in the Rates and Fees attached hereto as Exhibit A, and incorporated herein by reference.

**Section 4.** All resolutions and parts of resolutions in conflict with the provisions of this Resolution are hereby repealed as of the effective date of the Rates and Fees adopted by this Resolution, provided that such repeal shall not affect pending actions by the Town for enforcement of any outstanding rates, fees and charges for the Town of Buckeye Municipal Airport.

**Section 5.** If any section, subsection, sentence, clause, phrase or portion of this Resolution is for any reason held to be invalid or unconstitutional by the decisions of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.
