## **RULES & GUIDELINES**

1. **Weight & Height Guidelines:** Chihuahua cannot exceed 10 pounds in weight & 9 inches in height
2. **Cost:** FREE (limited to 32 participants)
3. **Check-In:** The day of event pre-registers Chihuahua's must check-in by 11:30am or risk the chance of their spot being given away.
4. **Start Time:** The first heat/race will start at 12:00pm.
5. **Leash:** All dogs must be kept on a leash at all times. (except during the race)
6. **Waste & Clean-Up:** Please bring clean up material with you. Owners/handlers are responsible for cleanup of dogs. Owners/handlers found not cleaning up after dog will be disqualified.
7. **Human Handlers:** Each dog participant requires two human handlers. One human will place their dog into the starting box and the other human will be at the finish line.
8. **Encouragement:** The human at the finish line may verbally encourage their dog. NO FOOD, TOYS OR OTHER ITEMS are allowed.
9. **Length of Race:** Each race is approximately 25 foot long.
10. **Interference:** Owners, participants and guests may not interfere, touch or handle Chihuahua's during race
11. **Race Qualification:** All Chihuahuas will participate in a minimum of one heat/race.
12. **Advancements:** 1st place finisher will advance to next heat/race, unless 1st place ties which will result in both finishers advancing to next heat/race.
13. **Use of Images:** The City of Buckeye retains all rights to use of photos and videos in future publicity and advertising.
14. **Awards:** Prizes will be awarded to the top Chihuahua finisher at end of competition.
