Question: The Map for Prospector way has red and yellow line. Are they both included as part of the work to be completed?

Answer: No. The red outline is included. The yellow outline is not included as part of the project.

Question: How many tests have to be performed on the concrete and asphalt?

Answer: The requirement for this project is 1 test for each on the concrete and asphalt.

Question: Do we have to meet ADA requirements on this project?

Answer: Yes.

Question: What do we do with the Root Barrier?

Answer: Cut and go straight down.

Question: Is there concrete on both sides by the mailbox on the Airport map?

Answer: Yes.
