The following questions were presented by Contractors at the Pre-Proposal Conference on September 20, 2016 as follows:

**Question:** Are there areas that will require Officers at Traffic Signals and 2/4 way Stops on this project?

**Answer: Yes. Check and Review all signals and stops with high volume traffic and stops where pedestrians may cross and include price. At Warner and Miller signal a pilot vehicle is required to escort traffic through the arterial while one side is treated then flipped to the other side when dry. On the Festival Arterial at Canyon Spring Rd. and Desert Vista Rd. stop sign Officers will be required.**

**Question:** When is the Start Date?

**Answer: The Start Date is anticipated for the last week of October.**

**Question:** Do we need to remove RPM's or just the ones that need to be replaced.

**Answer: Yes. Check with the Project Manager on all that are questionable in order to provide accurate pricing.**
