

**RESOLUTION NO. 25-19**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF BUCKEYE, ARIZONA, ADOPTING A NOTICE OF INTENT TO ESTABLISH NEW OR INCREASED FEES RELATED TO CEMETERY SALES, AND TO MAKE AVAILABLE TO THE PUBLIC A WRITTEN REPORT IN SUPPORT OF THE PROPOSED NEW OR INCREASED CEMETERY SALES FEES.**

**WHEREAS**, pursuant to the provisions of A.R.S. § 9-499.15, the Mayor and City Council (collectively, the “City Council”) of the City of Buckeye (the “City”) may increase fees and charges within the City where (i) a schedule of the proposed new or increased fees or charges has been prepared that includes the amount of the proposed new or increased fee or charge, (ii) a written report or data supporting the new or increased fee or charge has been prepared and made available to the public, (iii) a notice of intent to establish new or increased fees or charges has been adopted, and (iv) the schedule of the proposed new or increased fees or charges and the written report or data that supports the proposed new or increased fees or charges is posted on the home page of the City’s website at least sixty (60) days before the date the proposed new or increased fees or charges are approved or disapproved by the City Council; and

**WHEREAS**, the City has prepared a schedule of the proposed new or increased fees or charges for the Fees related to Cemetery Sales and a written report supporting the proposed new or increased Cemetery Sales Fees (the foregoing schedule and written report hereinafter collectively referred to as the “Cemetery Sales Report”) that includes fees for the expansion of the cemetery, and providing for columbarium niches, disinterment and polyliner vaults; and

**WHEREAS**, the City Council desires to declare their intention to establish new or increased fees or charges for Cemetery Sales Fees as described above consistent with the findings of the Report and to post and circulate the documents in support of the increase pursuant to A.R.S. § 9-499.15.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BUCKEYE, ARIZONA**, as follows:

Section 1. That this Notice of Intent to establish new or increased fees or charges for Cemetery Sales Fees is hereby adopted.

Section 2. That a Council meeting on the proposed modifications and new or increased fees or charges for Cemetery Sales Fees shall be held before City Council on June 18, 2019 at 6:00 p.m. in the Council Chambers, 530 East Monroe Avenue, Buckeye, Arizona.

Section 3. That the Cemetery Sales Report in support of the proposed modifications and new or increased fees or charges for Fees related to Cemetery Sales shall be available to the public beginning April 17, 2019, in the office of the City Clerk, 530 East Monroe Avenue, Buckeye, Arizona, on the homepage of the City’s website, and shall be circulated by social media or other electronic communication tools.

Section 4. That this Notice of Intent shall be posted no later than April 17, 2019 on the homepage of the City's website and shall be circulated by social media or other electronic communication tools.

Section 5. That the Mayor, the City Manager, the City Clerk, the City Attorney, and the City Fire Chief are hereby authorized and directed to execute all documents and take all steps necessary to carry out the purpose and intent of this Resolution.
