Further, you agree that the City shall have the right to offer alternative arrangements or otherwise correct any discrepancies in the description of any plot or grave without any liability to you for such alternative arrangements or corrections.

By signing the Buyer agrees to the terms and conditions of this agreement with the City of Buckeye and knowledge they have read and understand the rules and regulations of the Louis B. Hazelton Memorial Cemetery.
